

**RESOLUTION 04-04-12-1**  
**AVON TOWNSHIP RESOLUTION ESTABLISHING**  
**PRECINCTS AND POLLING PLACES**

**WHEREAS**, the legislature of the State of Minnesota has been redistricted; and

**WHEREAS**, Minnesota Statute section 204B.14, subd. 3 (d) requires that precinct boundaries must be reestablished within 60 days of when the legislature has been redistricted or at least 19 weeks before the state primary election, whichever comes first;

**NOW, THEREFORE BE IT RESOLVED** that the Avon Township Board of Supervisors, County of Stearns, State of Minnesota hereby establishes the boundaries of the voting precincts and polling places as follows:

**Precinct 1 (polling place: Avon Township Hall, 16881 Queens Road, Avon, MN)** is described as follows: That part of Avon Township, Township 125 North, Range 30 West, Stearns County, Minnesota, lying in Sections 1 through 24 and Sections 28 and 29; **less and except** that part of said Sections in said Avon Township annexed into and being a part of the City of Avon, Minnesota; **also less and except** that part of said Sections 19, 20, 28, and 29 in said Avon Township lying southerly of the south line of Lake Wobegon Trail also being the south lines of Census Block Numbers 271450104022051 and 271450104012020; **also less and except** that part of said Sections 14, 22, and 23 in said Avon Township lying southerly and easterly of Stearns County Road Number 155; **also less and except** that part of said Section 13 in said Avon Township lying southerly of 355<sup>th</sup> Avenue and westerly of 140<sup>th</sup> Avenue; **also less and except** that part of said Section 24 in said Avon Township lying westerly of 140<sup>th</sup> Avenue and southerly of the south line of Census Block Number 271450104011037.

**Precinct 2 (polling place: Avon Township Hall, 16881 Queens Road, Avon, MN)** is described as follows: That part of Avon Township, Township 125 North, Range 30 West, Stearns County, Minnesota, lying in Sections 13, 14, 19, 20, and 22 through 36; **less and except** that part of said Sections in said Avon Township annexed into and being a part of the City of Avon, Minnesota; **also less and except** that part of said Sections 19, 20, 28, and 29 in said Avon Township lying northerly of the south line of Lake Wobegon Trail also being the south lines of Census Block Numbers 271450104022051 and 271450104012020; **also less and except** that part of said Sections 14, 22, and 23 in said Avon Township lying northerly and westerly of Stearns County Road Number 155; **also less and except** that part of said Section 13 in said Avon Township lying northerly of 355<sup>th</sup> Avenue and easterly of 140<sup>th</sup> Avenue; **also less and except** that part of said Section 24 in said Avon Township lying easterly of 140<sup>th</sup> Avenue and northerly of the south line of Census Block Number 271450104011037.

Attached to this resolution, for illustrative purposes, is a map showing said precincts and the location of the polling place (Avon Township Hall, 16881 Queens Road, Avon, MN).
