Minutes of the Meeting of the Avon Township Board of Canvass

- 1. **Call to Order**: LeRoy Gondringer called to order the meeting of the Avon Township Board of Canvass at 9:05 PM.
- 2. Roll Call: Present LeRoy Gondringer, Chad Klocker, Kelly Martini, Rich Sanoski, Stephen Saupe.
- 3. **Business**: The purpose of this meeting was to certify the results of the March 12, 2024 Avon Township Election. The following information was presented:
 - a. Poll hours/Set Up Polls were open from 2:00 until 8:00 PM at the Avon Township Hall. There were 11 polling stations (5 stand-up, 5 sit-down, and an assistive voting machine OmniBallot).
 - b. Election Judges There were five election judges (Deb Angulski, Duane Fasen, Marion Gondringer, Lisa Gilk, and Kelly Martini, *Head Judge*).
 - c. Election results are summarized in the tables below:
