

Minutes of the Meeting of the Avon Township Board of Canvass

Tuesday, March 9, 2021

1. **Call to Order:** Mike Linn called to order the meeting of the Avon Township Board of Canvass at 8:15 P.M. This meeting was virtual and available via Zoom at <https://csbsju.zoom.us/j/991099941453>.
2. **Roll Call:** Present – Kelly Martini, Mike Linn, Ken Mergen, Rich Sanoski, Stephen Saupe.
3. **Business:** The purpose of this meeting was to certify the results of the March 9, 2021 Avon Township Election. The following information was presented:
