

# CITY BUILDING PERMITS

The turnaround time to obtain a building permit is a minimum of 10 days. Please make sure you submit your building permit application in enough time for it to be processed by Avon City Hall. Please remember the Zoning Administrator and the Building Inspector both need to review the application and sign off on all projects. The Building Inspector stops in the office two days a week. Please plan accordingly as to when you

will be starting your project. Thank you.

As of May 15, 2009 the police department has responded to 500 calls for service this year.

As spring and summer approach, the police department has received numerous complaints regarding animals on private property, in city parks, and at the elementary school playground. All dog owners are responsible for their animals and the mess they may leave behind. City Ordinance #91 requires that dogs need to be under the control of their owners at all times and must be on a leash when in public. The ordinance also requires that the owners pick up after their dogs. The number one complaint that we receive is that dogs go into parks and the beach and leave behind feces that are never cleaned up by the owner. I know that many dog owners do pick up after their dogs, but I am asking those that don't to please start. The police department has the discretion to issue citations for violations.

All dogs in the City of Avon are required to be licensed. A license can be purchased at city hall for \$5.00 annually. The police department has a volunteer intern on staff this summer and one of his projects will be to identify dogs within the city and determine if they are licensed or not. If we find out that your dog is not licensed a letter will be sent out to you regarding this matter. Licensing provides the police department the ability to return your dog if it gets loose and also requires all dogs to stay current on vaccinations. If the police department continues to receive large numbers of complaints, citations can be expected.

The beach will soon be open again for the season and the police department is going to continue with the beach patrol program that was implemented last summer. The police department will have staff on the beach during busy periods monitoring behavior. There are four large signs on the beach which clearly state beach rules. The signs also state that there will be zero tolerance for violations. The police department truly wants to make the **beach** a safe, family-friendly environment where people can enjoy themselves.

Reminder: Anyone choosing to drive golf carts within the city limits and on city streets needs to purchase a golf cart permit from the city for a cost of \$20.00 per year. Permits can be purchased at the police department. Golf carts cannot be driven on county roads, but county roads may be crossed. City Ordinance #73.08 addresses the use of golf carts within the City of Avon.

#### UNDERSTANDING YOUR ASSESSMENT

Property owners who are requesting for the first time the classification and assessment of their property as class 1b blind/disabled homestead must now file an application with the county rather than the state.

What is the special homestead classification? It provides a reduced class rate for property owned and occupied by any person qualifying as blind or as permanently and totally disabled.

**Who qualifies?** Any person (or their spouse) who is blind or permanently and totally disabled may qualify and receive the full benefit. A blind or disabled relative of the property owner might qualify for the special homestead if they occupy the home. A home that is owned by a blind/disabled person that is homesteaded by a non-blind/disabled person does not qualify for this classification. A disabled veteran may be eligible if the property is not receiving the market value exclusion from the Disabled Veterans Homestead.

The law states that the blindness or disability had to take place on or before June 30<sup>th</sup> of the year the applicant is filing for the special homestead classification. "Blind" means a person whose visual perception does not exceed 20/200 in the better eye with corrective lenses, or, if it is greater than 20/200, the condition comes with a limitation such that the widest diameter of the person's view subtends an angle no greater than 20 degrees. "Disabled" is a condition that is permanent and totally incapacitates a person from working at a job that produces income. The person must be receiving payments from a qualifying agency (i.e. Social Security Admin, Veterans Admin, Welfare Supplemental Security, pension plan, workers comp, or an insurance program) because of the disability.

**How do you apply?** Complete the application for Special Homestead Classification: Class 1b Property. This form may be requested by writing, e-mailing, calling, or visiting the county assessor's office or at: www.co.stearns.mn.us/1497.htm. It's that time of year when we are all trying to clean up our lawns by removing leaves, thatch and mower clippings. If you are a resident in the City of Avon, part of your refuse and removal service is the removal of this lawn "debris" from April

1<sup>st</sup> to November 31<sup>st</sup>, weather permitting! Bueckers City Sanitation will haul away your leaves, thatch and mower clippings if it is prepared properly. This waste must be bagged and weigh less than 50# per bag. The bags should be placed next to your recycling and not by the trash. This debris is picked up the same day as your recycling and refuse pickup! Please note, small "twigs", must be no larger than 1 inch in diameter and

must be less than 3 feet in length to be picked up.

If you have any project where the debris does NOT fit into the above category, such as tree removal, trimming or shrub trimming, removal,



you need to haul the debris to the city compost site located at 300 Angelfish. The compost facility is open daily to city and township residents.

At the Township Annual meeting held March 10, the Township residents in attendance instructed the Township Board of Supervisors to appoint a **Township Facilities Task Force**. The role of this committee will be to examine the facilities space needs of the Township and recommend to the Township Board a plan of action. The residents felt we needed to move forward with a Facilities Committee for various reasons.

The primary reason for the space needs assessment is due to the fact that the snowplowing contractor the Township hires has indicated he would like to discontinue snow plowing for the Township. This prompted the Township to explore hiring a different contractor. The contractors we have consulted were either plowing snow for another Township and were not interested in expanding, or were just not interested. The other option explored was for the Township to buy equipment and plow the snow ourselves. After visiting with other Townships that own their own equipment, we became convinced we could actually save money for the taxpayers of our Township if we built a maintenance building, bought snow plow trucks, and hired someone to operate them.

> Other areas of concern for the Township include having а permanent place to vote and hold public meetings as well as the need for a central, secure location to store official Township records. Township Currently the meetings are held at Avon City

Hall and elections are conducted at St. Benedict's Parish Center. Official Township records are stored in a number of locations, including City Hall and various Township Officer's homes. We are confident the committee will access the present and future space needs of the Township and develop a common sense plan that will benefit all residents of Avon Township.

After the Task Force completes the building needs assessment of the Township they will make a recommendation to the Township Board. The Board will then schedule a meeting at which the Township residents will be invited to review the recommendations of the Facilities Task Force and solicit additional comments or ideas on how to address the building concerns outlined. The final decision to construct a Township Facility will be made by the residents of Avon Township.

In April the Township Board conducted the yearly road inspection tour and have identified areas that need attention. Overall the Township roads are in good condition with just a few exceptions. We will need to do some major repairs on a portion of 182nd Avenue and minor repairs on a few other roads. We are looking at rebuilding the portion of 165th Avenue north of Queens Road. We are also cutting brush along roads and other general maintenance work. Please drive with care when you come upon township maintenance workers. Contact one of the Township Board officers if you see a road issue that may need our attention.

The Township Board of Supervisor meetings are the first Wednesday of each month at 7:30 pm. Both meetings are held at Avon City Hall.
