- 2. **Smith Interim Use Permit** Mr. Jeremiah Smith contacted the Town about installing a double-wide mobile-home on the Ritter farm where he works. He will need to complete an Interim Use Permit application. The property owner will need to sign it. A public hearing will need to be held.

- 1. **Joint Powers** Gondringer attended the recent Joint Powers Board meeting and reported that the City wants to change the percent of residents required for opting into the City from 60% to 51%. A public hearing about this issue will be held at the 2012 annual meeting of the Joint Powers Board.
- 2. **CAPX2020** Gondringer reported that the Administrative Law Judge has issued her findings of fact and sided with the position of the Town by recommending Route G with option 11. The Town is pleased with this ruling.
- 3. **Roads** several roads in need of repair were discussed; all had been identified during the recent road inspection.
