

# Minutes of the Meeting of the Avon Township Board of Canvass

Tuesday, March 11, 2025

Avon Town Hall; 16881 Queens Road, Avon (MN)

1. **Call to Order:** Bryan Rassier called to order the meeting of the Avon Township Board of Canvass at about 9:30 PM.
2. **Roll Call:** Present – LeRoy Gondringer, Kelly Martini, Bryan Rassier, and Stephen Saupe. Absent: Chad Klocker. A quorum was present.
3. **Business:** The purpose of this meeting was to certify the results of the March 11, 2025 Avon Township Election. The following information was presented:
  - a. Poll hours/Set Up – Polls were open from 2:00 until 8:00 PM at the Avon Township Hall. There were 10 polling stations (*4 stand-up, 5 sit-down, and an assistive voting machine – ExpressVote*).
  - b. Election Judges – There were seven total election judges (Deb Angulski, Jacque Biniek, Duane Fasen, Marion Gondringer, Lisa Gilk, and Stephen Saupe, *Head Judge*).
  - c. Election results are summarized in the tables below:

- a. Supervisor (*three-year term: 2025 –2028*): Craig Blonigen
- b. Treasurer (*two-year term: 2025 – 2027*): Kelly Martini

5. **Certification:** Gondringer moved to accept and certify the election process and results of the 2025 Avon Township Election declaring Craig Blonigen the winner of the race for Supervisor for a three-year term, and Kelly Martini the winner of the race for Treasurer for a two-year term. Rassier second. All in favor. Motion carried.

6. **Adjournment:** Motion to adjourn the meeting by Gondringer at about 10:00 PM. Rassier second. All in favor. Motion carried.
